They will be enabled to understand the types of crimes committed as well as biological, psychological and situational factors and to take a critical approach to real or simulated crime cases.

Course Description: This course approaches knowledge and understanding of criminal behavior and the impact of crime on individuals and society from developmental, cognitive-behavioral, and other psychological perspectives. The basic premise of the course is that multiple variables influence people's behavior and requires attention to how these factors interact with situational variables. During the course, topics such as criminological theories, biological and psychological models of criminal behavior, crime and mental disorders, juvenile delinquency, aggression and violence, communication				

with criminals and judicial processes will be examined.
